

## Contract Agreement

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT, made this 5<sup>th</sup> day of October, 2022 between **Municipality of Mexico, Pampanga**, represented herein by **TEDDY C. TUMANG, Municipal Mayor**, hereinafter called the "Entity" and **THREE-IN-ONE CONSTRUCTION & TRADING**, with office and business address at San Isidro, Bacolor Pampanga represented herein by **JERRY D. TULLAO**, hereinafter called the "Contractor".

WHEREAS, the Entity is desirous that the Contractor execute **VARIOUS REPAIR OF TWO CLASSROOM BUILDING LOCATED AT SABANILLA E/S, SABANILLA, MEXICO, PAMPANGA** (hereinafter called "the Works") and the Entity has accepted the Bid for **Four Hundred Seventy-Two Thousand Six Hundred Thirty-Seven Pesos and 95/100 Centavos (Php472,637.95)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

That the Contractor in case of delay in the completion of work shall be liable for liquidated damages of 0.70 multiplied by the contract price minus the value of the completed portions of the contract time divided by the contract time reckoned in days. The whole work of the contract shall be completed within **Seventeen (17) calendar days** in accordance with the Provisions of the Bid documents.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Drawings/Plans;
  - (c) Specifications;
  - (d) Invitation to Apply for Eligibility and to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
